Talk for Scaffolders – by NASC – 15 September 2022

We were delighted that around 50 representatives from the Guernsey scaffolding industry met a the KGV for a briefing from Dennis Braithwaite of the UK's NASC – a real expert in scaffolding safety.

Dennis gave a very good presentation, highlighting a number of areas where safety needs to be properly addressed, followed by a good Q&A session.

GOSHA was pleased to arrange this presentation for members and non-members, which had the support of the Guernsey HSE Team, who also attended. Scaffolding has so many health and safety challenges and keeping those who work in the industry and those who may be affected by it safe is a real priority.

Scaffolding is essential to so many in Guernsey. Without it, so much would not be achieved and making sure all those who work in the industry or are affected by it is a job requiring discipline and a proactive approach, good equipment, good training, good practices and being ready should something go wrong.

The HSE has created an internet page within <u>www.hse.gov.uk</u> covering the basics of health and safety for any business.

The basics for your business

- Appoint a competent person
 - Choose who will help you manage health and safety in your business
- Prepare a health and safety policy
 - What a policy is and how it helps you manage health and safety
- Risk assessment
 - How to identify hazards and assess risks at work
- Consult your workers
 - Involve your workers and inform them about health and safety
- Provide information and training
 - Tell your workers what their health and safety duties are
- Have the right workplace facilities
 - Have toilets, washbasins and other welfare facilities workers need
- First aid in work
 - Advice on your first aid kit, training workers and appointing first aiders
- Display the Law Poster go to www.gov.gg/hse
 - You must display the poster or give workers the equivalent leaflet
 - There is one for businesses in Guernsey and one for those in Alderney
- Get insurance for your business
 - Find out why you may need employers' liability insurance
- The Law go to www.gov.gg/hse
 - Look at the website for guidance in the Health & Safety at Work Ordinance (1987) and for the General Guide applicable to the Bailiwick of Guernsey.
- <u>Report Accidents and Illnesses arising from Work</u>
 - You must report certain injuries, near-misses and work-related illnesses to HSE see the guidance on the website and you may find it interesting to view Guernsey's statistics.
